### AAUW of OREGON BOARD of DIRECTORS MEETING - SUMMARY Summer Leadership Conference – July 12, 2019

**Officers' reports:** President Georgia explained that all of the officers' reports have been posted on the state's Google Drive, and asked that Dina Press be added to our officer lists as the state's new C/U rep. Georgia asked about officer training and job descriptions. Claudia suggested that the descriptions put together by the Portland Metro Interbranch Council might be a start; she will send them to Georgia. After some review and perhaps reworking, job descriptions could be posted on the state website for branches to use. Grants Pass Branch uses what they call "officers' notebooks", which include descriptions of what previous officers did, all the who/what/where/ when/how of the position.

The state AAUW directory is posted on the state website in the members-only section, and is available to all AAUW of Oregon members with the password (included in each issue of the Oregon News)

**Special Projects Fund report:** Penney Hoodenpyle explained that this fund has 501(c)(3) IRS status, and stated that "it is separate from AAUW of Oregon". The fund's bylaws have been submitted to the state Governance Co-chairs for review. Penney's earlier report, submitted at the state convention in April, was published in the *Oregon News*. The Fund is used by eight branches. A discussion of AAUW Affiliates and IRS requirements followed. Georgia suggested meeting by Zoom to discuss this further.

**Convention Chair** Betsy McDowell reported on the convention evaluations (compiled by Mary Ellen Dello Stritto). With 68% of the forms were returned, reviews were positive.

- Good publicity before the meeting helped explain the strong attendance.
- Although convention workbooks cost \$5 each, attendees really like having one.
- Enrichment activities were very well liked.
- 82% of attendees recommended dropping delegate voting. A discussion of "One Member One Vote" plan followed. Governance co-chairs Betsy and Claudia suggested that they work with Ilga Ross to research this issue, and present options at the Fall state board meeting.
- Attendees loved the new fundraiser event.
- There were complaints about the business session being split into two different times.

**2020 Dual State Convention** will be held with Washington State AAUW in Vancouver, April 17<sup>th</sup> -19<sup>th</sup>. Events coordinator Nancy Brown explained that we will be using the Heathman Lodge in Vancouver. The challenge will be getting enough local and Portland-area people to stay overnight at the hotel. The convention committee will be inviting members from Idaho, Alaska, Hawaii and Montana to join us. AAUW CEO Kim Churches will be attending. There was agreement that we also need a speaker well known enough to encourage attendance.

The **nominating committee** update was given by Pat Squire. Because of the resignation of secretary Kristin Mauro, there is an immediate need for a secretary.

**Finance** VP Sarah Elmer referred to her financial reports that were posted on the state's Google Drive site. The records are not yet finalized for the June 30<sup>th</sup> year-end. Once they are, they will be sent to a CPA for review in August. Several new budget items were added this year. Georgia added the cost of state officer name badges. The new microphone system was added to the Tech budget. Money set aside for sending a student to NCCWSL (National Conference of College Women Student Leaders) was not used this year so it will carry over to the next year.

On behalf of the Finance Committee, Sarah Elmer **moved the adoption of the proposed state budget** as printed; the vote was taken and the **motion passed**.

## PUBLIC POLICY — FALL 2019

Hello One and All -

After a tumultuous legislative Session, things have begun to settle down. I've been meeting with a number of coalition partners and advocates in order to determine what issues we will be working on in the next Sessions. I will also say that we need to be prepared for walkouts being business as usual, but one never knows.

I understand that the Oregon Department of Education is already putting at least one full time Title IX Coordinator position into action. Thank you so much to all of you who attended pre-Session Student Success forums and sent in emails urging your legislators to approve this funding. You made a difference and, in the bargain, underscored AAUW of OR's ability to advocate in Salem.

One of our major priorities for the 2020 [short] Session is passing an age discrimination bill. As you may recall, if an employer can come up with one reason other than age for an adverse employment decision - even if that reason is directly related to age - then courts have said that an aggrieved employee can't seek redress for the decision based on age discrimination. We want to say that age discrimination is just that - age discrimination, and it should be illegal. We will be working with AARP of Oregon to move this bill forward. You just may be hearing from me about contacting legislators to support the bill. Stay tuned!

AAUW of OR is also supporting campaign finance reform. The details have yet to be worked out, but we are looking to support a bipartisan, fair process. Representative Dan Rayfield, along with election policy experts and campaign finance reform legislative leaders, is going to present a statewide tour in September. Forums will feature a history of Oregon campaign finance reform, discussion of the 2019 legislature's accomplishments, and a community discussion about the future of campaign finance reform. All of the events run from 7:00 to 8.30 p.m. Here are the locations:

**Pendleton** branch will focus on programs which reflect the results of the passage of the 19th Amendment, including Eastern Oregon Women in the News, Cultural Sustainability as Reflected from the Confederated Tribes of the Umatilla Indians, as well as the effect of Climate Change on Mosquitos. Ongoing successful efforts include the annual grapefruit sale fundraiser, the annual showing of short documentaries by Helix High School students, and the December celebration of wine, food and chocolate.

**Baker** branch recommends Days for Girls which can demonstrate how a branch and other volunteers can provide hygiene kits for use in areas of the world where menstrual products are not readily available. There is an online site. A member of the Caldwell, Idaho group presented this information to Baker.

Baker branch applied for a grant and was a winner in the All Abilities playground funding via Portland Trailblazers Moda Assist program. This will add almost \$50,000 to the local project goal of \$250,000 sought by a number of community organizations. Baker viewed a Suffragette DVD which could be shared.

**Astoria** – Best Program: WINGS - Women Interested in Going Back to School, co-sponsored by Seaside AAUW and Clatsop Community College, is a free one-day conference designed to inspire and inform women by offering workshops on non-traditional careers, career planning, degrees, certificates and pathways, math anxiety and other related topics. Breakfast, lunch and free childcare have been offered, to help women fit this important day into their busy schedules. This event has been well-supported in Clatsop County for more than 15 years. March is Women's History Month and the Astoria Branch will be holding a women's networking event that month.

**Yamhill County** put on an Equal Pay Day bake sale, in cooperation with Linfield College. This new Branch is able to meet in the College Library and is pleased with the developing rapport with the college. During the bake sale, they talked to many Linfield students and faculty. Most were aware of the pay gap but not what equal pay day was. Many cookies were sold — at \$1 for white men, 79 cents for white women and 65 cents for both genders of minorities (the price is an average of the pay for those groups). Branch members contributed the cookies and proceeds went to Students Advocating for Gender Equality (SAGE) for their programs, one of which AAUW Yamhill County helped sponsor (with them and others at Linfield) the week after equal pay day. #### **Gresham Branch Provides Equal Pay Program to MHCC Students**

Although we have not been successful in the development of a student group at Mt. Hood Community College, we have made some very good contacts. As a result, we were invited to provide a program for students during Women's History Month about the issue of equal pay.

Sharron Noone, our co-Vice President for Communications, was the presenter at the March 13, 2019 program. Her career in Human Resources provided an informative and interactive talk on payment discrimination. She developed a PowerPoint deck utilizing the Equal Pay Act materials available on the AAUW Oregon website and on the National website, and based on her own experiences. Arlene Lemieux set up a table with literature on AAUW and equal pay for students to pick up. It was a very good program plus gave our branch an opportunity to be more visible in the community. We hope to continue a productive relationship with MHCC and to provide more community programming in the coming year.

#### Dr. Jim Moore Delivers "Fake News" Program to Hillsboro/Forest Grove Branch

"Fake News – Threat or Fact" given by Dr. Jim Moore, well-known political and newspaper analyst, was one of the best programs Hillsboro/Forest Grove Branch had last year. Dr. Moore's presentation answered this question: *Will this nomenclature become a permanent element of civic discourse, or is it particular to our current political climate?* Moore gave examples of how fake news came up in the past; how it is affecting our thinking and judgement currently and will in the future. Moore delivered information using humor in an interactive style that kept people talking and asking relevant questions.

In addition to his demeanor, his wide knowledge and fair treatment of this subject made him a wonderful resource and drew many of our members as well as attendees from the general public to this program. The Branch met privately after the program to debrief and determine how our branch could best get the word out. We all agreed that what made this program stand out was the quality of the presenter and our ability to debrief after the program and apply what we learned to our branch.

#### Lake Oswego Branch - Hosting Program About Foster Care

A good program requires an interesting topic and a good speaker. Even more important, a good program is mission-based and serves either to inform and support work that is being undertaken by the Branch or lays the foundation for future action. The Lake Oswego Branch has had many of these programs over the years, but I want to focus on our program for October 2019. Lake Oswego is hosting a joint meeting with the Portland Branch. We have invited two young women from Oregon Foster Youth Connection to speak. These are women who have aged out of foster care in Oregon and now serve as advocates for improving the foster care system through their activism and leadership. Some of the issues with which they are concerned are preventing homelessness for foster youth, supporting youth in care who are 18-21, providing education in sexual awareness and sex trafficking, and giving support to foster parents. The Lake Oswego Branch is particularly interested in finding areas where we might be of assistance through our Advocacy Committee. All are invited.

#### Transgender Topic Attracts 200 to Portland Branch Program

AAUW Portland Branch created an educational program in response to members' questions about the Transgender community. Our branch proposed "We Can Listen" (designed to create opportunities to strengthen the growth of individuals and community voices) organized by The Old Church (TOC) in Portland. We met for eight months with personnel from the TransActive Gender Project at Lewis and Clark graduate school; Gender and Sexuality studies at Portland State University; OHSU's Transgender Health program; Kaiser Permanente's Gender Health; Advance Gender Equality (AGE); and TOC. The Oregon Commission for Women was an active sponsor assisting in the dissemination of information for the event. The program was also supported by a grant from AAUW Oregon.

The program opened with music from the transgender acapella group "Acchord", followed by a conversation with four transgender adolescents and their mentor. Next, four transgender professionals discussed how much has changed in the struggle for acceptance and civil rights, and what the next steps are in ensuring that transgender youth and adults are protected and nurtured as members of society. The last presenter, an 11- year-old transgender girl, described her "perfect world of the future" for transgender individuals.



In addition to exceptional content and a slideshow depicting definitions related to transgender expression, the audience left with two handouts: terms and terminology and resources for further information. The program was recorded by TOC as a podcast as well as by a local radio station as part of a national conversation.

#### Salary Negotiation Relates to Equal Pay Act, Work Smart Training for Tigard Branch Ilga Ross, President

Tigard Area branch member Marsha Brockmeyer shared her professional expertise on salary negotiations in a program that attracted many young working women. The program complemented the Work Smart online training. Marsha's degree is from OSU in Business with concentrations in Management, Marketing and Organizational Behavior. She is a coach, mentor, trainer, and workshop facilitator who had careers in Oklahoma City, Dallas, Boston and New York City. This program reminds us that the best speakers and the greatest expertise may lie within our own membership.
