

Convention Highlights

"Together Women Make History" is the theme of our 2020 Convention and you won't want to miss this combined event with Washington State! Here's why:

Theme: The theme has several meanings:

It is a commemoration of the 100th anniversary of the 19th amendment, giving most women the vote Many of those women worked together, across groups, to make the passage of the constitutional amendment possible. And this year we are working with our sisters in Washington State to hold this convention

A number of our speakers will expand on the theme by talking about new potential audiences for AAUW, and the effectiveness of working together with other like-minded groups

Location: This convention is being held at the beautiful Heathman Lodge in Vancouver.



Items to Note:

AAUW-OR Lobby Day will be held **February 24, 2020 in room 50 in the basement of the Capitol Building in Salem.** The title of the session this year is "**Women Legislators in Salem: Getting There, Staying There.**" We will discuss how we can encourage women to run for public office and get elected. I am looking forward to all these events and plan to attend as many as possible. I also plan to visit with legislators. I hope many of you will join me!

Update from AAUW National... Many of you are aware that AAUW National has been making major changes to return the organization to a position of fiscal sustainability. The new Strategic Plan is a guiding force in focusing on AAUW activities. A significant reduction was made in annual expenses (\$24M to \$16M) and staff (107 to 40). This has affected response time to state and branch officers and members who have requested assistance and answers to questions. The website will be undergoing changes this year as more resources are put into improving it for member and donor use. AAUW leadership says that it is increasing transparency to ensure that members know and understand the changes being made. Stronger revenue pipelines are being developed that are based on realistic goals and expectations for the organization. AAUW is increasing its public/external face through high-level presence at conferences, initiatives, and media, thus increasing awareness and support of AAUW and its mission.

This is a time of exciting change and improvement, with Kim Churches as CEO. I encourage you to attend the joint WA/OR Convention being held on April 17-19, 2020 at The Heathman Lodge in Vancouver, WA to hear Kim talk more about all of this. I am sure she will be as open to your questions as she was when she attended our convention last year.

AAUW CEO **Kim Churches** presented a webinar exclusively for members – <u>Our Path Forward to Gender Equity</u> -- in mid-October. It is important that all members see/hear this webinar. New LAF Case Support

"In September, the AAUW Legal Advocacy Fund adopted a new pay-equity lawsuit, Freyd vs University of Oregon. The case challenges the pay discrimination faced by Jennifer Freyd, a professor paid substantially less than her male colleagues who hold the same positions, are junior to her, and are no more accomplished. The disparity is primarily due to retention raises, and the case will help establish whether such raises are considered a "factor other than sex" under the Equal Pay Act. AAUW also joined an amicus or "friend of the court" brief in support of Freyd's appeal."

The Heathman Lodge, a beautifully hand-crafted Northwest mountain-style lodge, embodies the geology and natural history of the Northwest. Massive peeled Douglas fir logs define the exterior portico and interior lobby with the distinctive entry guarded by a cast bronze statue of a Chinook chieftain and a stately totem pole dedicated to the memory of the Lodge's founder. Slabs of Columbia River basalt boulders, split and then hand-fitted together, form the lobby fire-place that rises in salute to a history that spans the millennia.

- Cross into Washington on I-5
- Take the WA-500 E exit (approx 2 miles from WA border)
- Follow signage to Vancouver Mall
- Take the NE Thurston Way exit from WA-500 E (approx 4.5 miles)
- Head north on NE Thurston Way
- Turn LEFT at NE Parkway Dr
 - LEFT onto NE Greenwood Dr: Heathman Lodge: 7801 NE Greenwood Dr

To Heathman Lodge via I-205 (from Oregon)

- Cross Columbia River into Washington on I-205
- Take the WA-500 exit (approx 4 miles from border)
- Head west on WA-500
- Take the NE Thurston Way exit from WA-500 (first exit from WA-500)
- Head north on NE Thurston Way
- Turn LEFT at NE Parkway Dr

Friday Afternoon Enrichment Tours

Enjoy enrichment tours in Vancouver, WA on Friday afternoon! Register ahead of time on the registration form, and either meet at the hotel to carpool, or go on your own. One requires a \$5 fee in advance.

Tour of New Vancouver Waterfront:

Carpooling will be available from the Heathman Lodge, leaving at 1:30.

Come see where the Pacific Northwest, as we know it, really started and where it is now. This is a 60-90-minute tour of the new waterfront starting at 2:00 PM under the northern base of the Interstate Bridge and moving west to the brand new and exciting Vancouver waterfront! Our tour guide, Pat Stryker, has been involved in helping preserve the historic nature of this "One Place Across Time" and planning ways to make it an exciting tourist attraction. Many unique public and private partnerships have been involved, and there are interesting stories to share. We will walk along the waterfront trail for an hour or so, with stops along the way, so please wear comfortable walking shoes. Although the tour is free, please do pre-register!

Paid parking will be directly in front of Warehouse 23, a restaurant and the first building west of the bridge. Directions to the new waterfront development: Cross I-5 bridge northbound and take the second exit (labeled 1B). Go north on the exit ramp to Mill Plain and turn left. Go west to Columbia Blvd., then left on Columbia and follow it to the waterfront. (If you go too far, you will be turn left and drive parallel to the river.) From other directions, go to Mill Plain Blvd. and drive west to Columbia Blvd.

Tour of Providence Academy in Vancouver:

Carpooling will be available from the hotel, leaving at 1:30.

Beginning at 2:00 PM on Friday, April 17, take this 90-minute walking tour (not always handicapped-accessible) of Providence Academy, a four-story building which was the tallest brick building north of San Francisco when it opened. Replacing a one-room school opened at Fort Vancouver in the 1850s, the Academy was built under the direction of Mother Joseph, sister of Providence. She used her skills as an architect, educator, artist, fundraiser and construction supervisor to complete the building. The Academy is listed on the National Register of Historic Places. Mother Joseph also opened a hospital near the Academy – the start of Providence Health systems in our area.

The cost of our private tour -- \$5 per person – is NOT refundable. Pre-registration is required. Registration deadline – April 3, 2020. Maximum number on the tour is 25. Money paid by people who do not attend will be donated to the Historic Trust which owns the building. (thehistorictrust.org.) Tour and shopping at Pendleton Woolen Mill in Washougal

Carpooling will be available at the hotel, leaving at 12:45.

Join this free one-hour tour of the Pendleton Woolen Mill in Washougal starting at 1:30 p.m. with Hudson's Bay member Sue Heise. Here you can see the process of making Pendleton blankets, from the state-of-the-art dye house, through spinning and weaving, to the finishing of their iconic blankets. After the tour, you can visit the Mill Store where you can select from Pendleton's array of womenswear, menswear, blankets and accessories.

Participants will be part of a public tour. Although the tour is free, please register no later than March 3 to ensure that you have a spot. If you want to drive to the mill yourself, from I-5 or I-205, take WA Route 14 east to Washougal. Turn left on 15th St., (now Washougal River Rd) and on your right you will see the Pendleton billboard. In 1924 the Congress granted birthright citizenship to American Indians, who had been classified as wards of the Federal Government as their legal guardian up to that point. This presentation dives into the when, what and how questions about that legislation to address the important "why?" questions. Why 1924? Why birthright citizenship? Why are notions about Indian citizenship crucial to understanding debates about other (potential) citizens, such as women, African Americans and immigrants?

Dr. Lomawaima is professor, School of Social Transformation, Arizona State University; scholar of Indigenous studies and histories; member of the National Academy of Education and the American Academy of Arts & Sciences. She has a Ph.D. in Anthropology from Stanford and started her academic career at University of Washington. She served on the faculty of University of Arizona in the American Indian Studies department, which she headed from 2005-2009. She has received numerous teaching honors. She is a member of the Creek Nation.

"Together Women Make History: How the Suffrage Movement Guides our Work Together Today"
This panel represents three distinguished women's organizations, two of them celebrating their 100th anniversary.
The panelists, all leaders in their organizations, will talk about their goals, and the importance of working together in 2020 and beyond. Women still have many obstacles to overcome, and while we commemorate 100 years since the passage of the 19th amendment, most of us agree we still have a long way to go. Join these visionary leaders as they talk about their organizations and the future working together.

Panelists:

Kim Churches (left) is chief executive officer, American Association of University Women (AAUW founded in 1881). Ms. Churches has had a number of leadership roles where she has worked on partnerships and external relations, including as managing director of the Brookings Institution, as an associate vice chancellor at the University of Denver, and a division director at the American Heart Association. She serves on a number of boards in Washington, D.C. including the International Women's Forum, an organization that represents women leaders in diverse fields.

Marge Easley (center) is a past president of the Oregon League of Women Voters (celebrating their 100th anniversary in 2020). Ms. Easley has held many leadership positions with the League over the past 27 years and is currently Clackamas County Action Chair. She is a member of the League's legislative action team and regularly advocates on a range of issues. During election season she moderates voters' forums and interviews candidates on TVCTV for the Video Voters' Guide.

Jeanie Martin (right) is governor, District 8, Zonta International (celebrating their 100th anniversary in 2020). Ms. Martin, whose district encompasses British Columbia, Alaska, Idaho, Oregon and Washington, is a 26-year member of the Zonta Club of Grants Pass, OR. She is retired from her public service position as a juvenile corrections office manager. She believes that gender equality can be achieved if we continue to lead with intent and inspire those around us to inspire others.

10:30-11:45 Workshop Sessions:

"They Persisted: How Oregon and Washington Women Achieved the Vote," Prof. Kimberly Jensen
Diverse Washington and Oregon women worked to achieve voting rights in 1910 and 1912 before the ratification of
the Nineteenth Amendment placed voting rights in the U.S. Constitution in 1920. Many of these activists were also a

part of that nationwide voting rights campaign leading to the amendment. This presentation will examine women's suffrage activism in these two states and will invite participants to identify continuing barriers to women's voting rights as the movement continues.

Kimberly Jensen is professor of History and Gender Studies at Western Oregon University in Monmouth, Oregon. She received her Ph.D. in women's and U.S. history from the University of Iowa and is a specialist on suffrage. She is the author of *Mobilizing Minerva: American Women in the First World War*, and *Oregon's Doctor to the World: Esther Pohl Lovejoy and a Life in Activism.* She is a board member of the Oregon Women's History Consortium.

"Inspiring Learning by Teaching Computer Skills to Minority Students", Trish Millines Dziko

Join this inspirational leader and educator as she talks about her passion for weaving STEM into project-based learning for minorities. Dziko created the nonprofit *Technology Access Foundation* with the aim of capturing the interest of children of color early and providing opportunities for them to become users and creators of technology. Learn about how her nonprofit, staffed mostly by women and minorities, started an after-school program culminating in technology-related internships and \$1,000 scholarships and how that Foundation now runs a sixth-through-12th grade public school partnership.

Ms. Dziko became a program manager at Microsoft in 1985 and later in her career became active in diversity. She was senior diversity administrator for Microsoft, traveling around the country to recruit college-level, technology-trained people of color. When she realized that pool was small, she left Microsoft to start the *Technology Access Foundation*. As she says, "You have it, you share it".

"Policy Café: Public Policy through the Lens of Diversity and Equity", Sandra Distelhorst and Karen Rosebaugh

The Policy Café is modeled after the World Café method used by many groups including diversity commissions, advocacy coalitions and AAUW. This highly effective café style forum uses small "round table" group discussion, guid-




ed by a group facilitator, to engage community members from different perspectives. This interactive session will demonstrate how to plan and host a Policy Café and participants will be able to take part in a mini session.

Now retired, she volunteers with Everett Community College's *Bridges* program and supports the *Communities of Color Coalition*. She advocates on behalf of several organizations and for gender rights through AAUW.

education related to the history of all women in Oregon. In 2012 OWHC led the statewide commemoration of the centennial of Oregon women gaining the right to vote.

As we begin to celebrate the 100th anniversary of the passage of the 19th amendment, OWHC is working to shed new light on Oregon's history of women's suffrage with educational programs on women's right to vote and the different roles all women have played in the history of Oregon. Their educational website recently launched the resource Century of Action: Oregon Women Vote 1912-2012. In addition, OWHC is working with the National Votes for Women Trail project creating a national online map of women suffrage movement sites in each state and suffrage markers around Oregon donated by the William G Pomeroy Foundation. Oregon 2020 was recently launched with interviews and news articles regarding suffrage in Oregon. The OWHC exhibit "Nevertheless, They Persisted: The Nineteenth Amendment and Women's Voting Rights" will be featured at the Oregon Historical Society starting in March.OWHC also provides educational programs for groups and institutions throughout Oregon on the history of all aspects of women's suffrage in Oregon.

"Sexual Assault: Where are we With Solutions?" Michele Roland Schwartz and Kate Hemann These expert speakers will discuss training and technical assistance being provided to sexual assault victim advocates, law enforcement officials, health care providers, sexual assault response teams, and campus-based professionals. They will present information on some positive changes in the law that should help victims, but will also let us know what still needs to be done.



Kate Hemann is a Washington Assistant Attorney General who works in the general Criminal Justice Division. She is also the Sexual Assault Kit Initiative (SAKI) site coordinator for the state of Washington, now a full-time job. This group seeks to test and investigate untested sexual assault kits. Previously she was a prosecutor in New York where she specialized in sexual assault cases.

Michele Roland-Schwartz is the executive director of the Oregon Sexual Assault Task Force, having served since 2013. She has provided service to survivors of sexual violence from diverse backgrounds as a case manager, crisis hotline worker, and hospital response advocate.

"Successful Branch Community Partnerships," Mary Williams

"Closing the Gender Gap for Nonprofit Boards and Other Leadership Positions," Kay Toran and Katherine Cleland

Did you know that Oregon and Washington are in the top ten of the least affordable states for center-based infant care? Or that families pay at least 30% of their income for this care? As we all know, the early years of a child's life are crucial for social, emotional and cognitive development. Our presenters will tell us about the importance of high-quality early learning programs for a child's development, school readiness and family well-being and will discuss policy strategies and solutions.

Jessica Vega Pederson is a member of the Multnomah County Commission and former legislator, and is author of a ground-breaking report "Pre-School for All". She spearheaded a year-long process that gathered community leaders from across many sectors, including education, business, housing, healthcare, and parents, to achieve this proposal.



Dr. Mary King is Professor of Economics Emerita at Portland State University.

Her academic research has focused on the economic conditions and policy strategies that expand opportunities for underserved populations. She is a leader in state public policy, a Rhodes Scholar and a 2006-07 recipient of an AAUW Postdoctoral American Fellowship to study the experiences of undocumented Mexican women in the Oregon labor force. She is coauthor of a recent study about Oregon's child care crisis: *Oregon's Unmet Child Care Needs*.

Andrea Paluso is executive director and co-founder of Family Forward. She is a social worker and policy wonk turned community activist. She has worked in public education, community health clinics and in international development. Andrea hopes that her organization's work will inspire and help parents, employers and policy makers to create the kinds of policies that work for today's families.

AAUW of OR State Public Policy Report

By now I hope all of you have put a star by February 24, 2020. That's the day AAUW of OR will have its 2020 Lobby Day. I am very grateful to the Ashland Branch for taking on the organization of this Lobby Day. *Regina Ayars* is serving as Chair. As usual, they have done a wonderful job, including setting up online registration. Here's the link: https://aauw-or.aauw.net/lobby-day-2020/. We'll be talking about *Women Legislators: Getting There and Staying There*. While you may not be thinking about becoming a legislator (more power to you if you are – and let me know!!), the information you will be hearing about will not only be interesting but will inform you a lot about the legislative process.

Although the 2020 Legislative Session is a short one, your State Public Policy Committee and Chair have been busy sorting through potential legislation. One of our key priorities is to get an Age Discrimination Task Force bill passed. As you may recall, a substantive bill to target ageism in the workplace did not make it past the finish line in the 2019 Session. This bill is a Task Force bill and doesn't provide remedies for the underlying problem, but we hope it will provide some needed momentum for a good bill to be successful in 2021.

Given what appears to be an impasse – although the circumstances seem to change by the minute – about the carbon / cap and invest bill, it's unclear what will take place in Salem during this Session (February 3 through *sine die* on March 8). Here are some of the issues that are percolating: campaign finance reform, firearms storage, a Student Health Survey that contains metrics for improving health, funding for co-location of domestic violence advocates within Department of Human Services offices and more.

While it may seem that public policy is same as advocacy at the legislature, it's far broader than that. An issue that AAUW of OR has consistently supported is requiring instruction of civics in our schools. To date, the legislative route hasn't been successful. One of the barriers is that civics isn't on "the test," and teachers are clearly overburdened with responsibilities to make sure their students do as well as they can. As a result, *Catherine Meyer* (Eugene) and I are working on finding out more about the process from an administrative or "inside" standpoint. This is not a task that will conclude quickly, but we are doing research and contacting OR Department of Education staff. Superintendent Colton Gill has been very helpful in directing our efforts. If YOU have an interest in joining us, please let me know! We will be glad to have you.
