SUMMARY REPORT for 2020 AAUW OF OREGON

Board of Directors Meeting
August 2, 2020, 2:04 – 4:02 p.m.

Note that the Board of Directors' Meeting and the 2020 Summer Skills Camp were very different from last year, as both were held on the computer application / platform called Zoom® which provided personal view of participants, conversation and discussion with one another, and an opportunity to share documents on-screen during the discussion. All documents referenced in discussion were shared with members prior to the meeting through the AAUW Oregon Google Drive® site or during the meeting via screen shares in Zoom.

In a review of their report in the *2020 Elected and Appointed Officers' Summer Skills Camp Report*, Sue Klumph and Pat Lehman noted their very productive discussions with current and retired presidents. These were fruitful, providing pertinent ideas for the Skills Camp sessions by identifying branch needs, plans, requests, and activities.

Following the July 30, 2020, Executive Committee decision, the Technology Committee is now a standing committee. The decision was important, given the ever-increasing role that technical devices are playing in state and branch activities, including, but not limited to, email, social media, and Zoom. The 2020 -21 Technology Committee chair, Georgia Applegate, is now a voting member of the Board of Directors as a result. Georgia discussed activities of the committee during 2019-20 and reviewed the platforms and equipment now available.

Zoom meetings with focused groups are planned following Summer Skills Camp (SSC):

District Directors
Branch Presidents
Membership personnel at branches (not all have a Membership VP)
Others as needed

Because of cancellation of state, National, and local activities due to the novel Corona COVID-19 pandemic, little money was spent since January 2020, leaving the state with an increase in funds.

Assuming that the pandemic ends, convention 2021 may be in Ashland, Coos Bay, or Florence. Nancy Brown and Pat Squire are still evaluating venues and balancing costs. If the pandemic continues, an in-person meeting may not be held. Stay tuned for more.

Many thanks to Trish Garner for her dedication to this important job and for the hours she has spent following the legislation and other hot issues in Oregon. This has been an unusually contentious and fractious year, with many diverse issues pulling at Oregon voters. Trish discussed the changes made to *Policy 800* to update, clarify, and bring current to National standards.

AAUW and Portland protests: The material prepared by Trish with support from AAUW members has been filed as an exhibit in the Police Reform activities and the testimony has been included in an upcoming resolution for legislative voting. A new initiative is “Civics” education. Trish commented that review of current textbook language and curricula reveals programs that do not address diversity in our culture nor racial equity. Work needs to be done to bring civics up to modern inclusivity expectations

Membership is down, changes in forms and payment are coming from National, membership trainings via Zoom are coming, and branches are asked to send newsletters to Pat Lehman, Sue Klumph, Pat Squire, and Gini Dideum to better share ideas and information.

The directory has been updated and a calendar of branch duties was added. *The Oregon News* will be sent by MailChimp to all members, with additional mailings to branch presidents for distribution.

Three key officers’ position are open; recommendations for candidates should be sent to Sue Klumph and Pat Lehman.

GOOD OF THE ORDER

Remind your AAUW branches and contacts that National and AAUW OR both say **no in-person meetings or activities** until the pandemic is resolved, which doesn’t seem to be a quick thing.

Board of Directors members were asked to suggest priorities from the *Strategic Plan for 2020-21* by August 20. See the AAUW of Oregon website for a copy of the revised plan.

PUBLIC POLICY REPORT

While COVID-19 has put a serious damper on person-to-person activities, AAUW of OR public policy is still alive and well! We are hoping that each branch will be coming up with some community-specific activities that will promote voting in the upcoming election. I don't have to tell you how important it will be for everyone to vote. As Sherry Schroeder (Medford) suggested to me, we should be checking with elections officials to make sure there are no special guidelines about voting and also identifying where ballot drop boxes are. And then making sure the community is aware of this information.

We also urge each branch to learn about the state and local ballot measures. They at least include Initiative Petition 57 - Sets up an independent Citizens Voting Redistricting Commission; Senate Joint Resolution 18 - authorizes the passage of laws regarding campaign contribution disclosures and political advertisements; Initiative Petition 34 - allows health care providers to administer psilocybin; Initiative Petition 44 - lessens the criminal penalties for certain drug offenses; House Bill 2270 - increases tobacco taxes. It is important to note that our current state budget -- which is already suffering due to the pandemic -- assumes the tobacco tax will pass. Please vote YES!

On the legislative side, we have been active in bolstering laws regarding police accountability. In the Second Short Session on August 10th, and with our support, the legislature passed a law significantly updating our use of force by the police.

We are also looking into following the lead of California and Washington in passing a bill that would require a certain number of women to be on corporate boards. The Ashland Branch is doing some serious research into this issue and intends to prepare a full report. which we can then use in our lobbying efforts. Way to go Ashland Branch!!!

AAUW OF OREGON POLICY UPDATE REGARDING CANDIDATES

At the 2020 AAUW of Oregon Annual Meeting in April, the AAUW of Oregon Policy #800 was reviewed to clarify candidate endorsement activities at the state and branch level. The board-approved updated version, effective immediately, has been sent to all state officers and all branch presidents.

This is a summation of a few of the main points of the new policy as it relates to branches:

- Branches may endorse candidates for appointive office but not for partisan office.
- Branches may NOT contribute money, mailing lists, or anything of material value to candidates for any elective office, partisan or nonpartisan.
- Before a partisan election, branches may have candidate forums to which all candidates in that election are invited. If three or more political parties have nominees for any office, branches may limit invitations to the two political parties receiving the highest number of votes in the last preceding general election.
- Branches with 501(c)(3) status may invite a public official who is also a candidate in a partisan election to speak on a subject pertaining to the incumbent's duties as a public official, as long as the incumbent does not discuss his or her candidacy for public office and does not use campaign funds to underwrite the appearance.
- All candidates running for the office(s) pertaining to the candidate questionnaire must have the opportunity to participate.
- Any member may endorse, as a private citizen, candidates for partisan elective office, contribute her/his/ their own money or anything of value to such candidates, and organize for the purpose of supporting such candidate(s) but such endorsement, contribution or organization cannot utilize the name of AAUW.

Please review the entire policy before planning programs with candidates.



Central District Elena Rae, District Director

All of our branches reported in, though as expected, there isn't much news since the last report. The task of proceeding with the disbandment of the Corvallis Branch has been passed to National by Oregon State Membership VP Gini Dideum after I was unable to reach their contact in order to get the paperwork completed. I asked the Albany Branch if they'd like what-are-you-up-to blurbs from me and maybe some of the board members for their outreach program, and followed up with a short paragraph about whatever it is that I've been doing. Or, not doing.

"Chalk the Vote," an Oregon Women's History Consortium program, was mentioned at Summer Skills Camp, and also by our Bend Branch. It involves artistically chalking out the text of the voting rights amendments/act on sidewalks and stairs, and posting the results to social media. Evidently this was one of the communication methods that was open to the people demanding their rights before these amendments and the Voting Rights Act were passed (maybe not the Social Media part).



Albany - The Branch has not had any additional meetings since our last report. To keep in contact with our members, our branch has been sending informative emails, and we did an extra newsletter letting members know what has been happening and what is coming. We have asked our members to send us information about their activities so that we may share in another newsletter via email. Bend - Bend Branch was rather in a holding position in 2019-2020, as no one would accept the presidency. Sarah Elmer, expert in all matters AAUW, became the administrative officer. The branch scheduled three meetings for the year; alas, the third one, scheduled for spring, had to be canceled due to COVID-19.

We now have a full slate of officers and have scheduled monthly meetings via Zoom. We are even having training sessions for members unfamiliar with Zoom. Co-President, Kaitlin O'Donnell has arranged for a highly competent friend to teach several of us how to host the Zoom meetings. Kaitlin is already very accomplished with this and other matters digital.

We have planned the programs through winter and are confirming presenters now.

We plan to work with the League of Women Voters on Chalk the Vote during the last week of August.

That's about it for Bend. I (Jane McEldowney) was able to sit in on most of the Summer Skills Camp Sessions and really was impressed!

Eugene-Lane - From holding branch committee meetings in outdoor park shelters, to preparing for small-group Zoom gatherings for our September general meeting (when we intend to hold our postponed 19th Amendment Readers Theatre event), we've been getting creative about keeping in touch with one another. We've also taken the summer to revamp our branch directory from print to online, overhaul our branch policies, gather materials to add to our historical archive (what a year it's been for that!), and generally plan for new leadership in the fall.

Salem - The noteworthy news from Salem Branch is completion of our Oral History Project, which was featured in the Summer Skills Camp online "program ideas" session. Nine of our Life Members shared their personal stories and information about the activities of Salem Branch through history. We video-taped the interviews; they are available on YouTube for anyone to see and hear. We were set to celebrate the Centennial of the Women's Suffrage by collaborating with our local Deepwood Museum and Gardens. An elaborate "tea" was scheduled featuring our resident actress, Gloria Holland and her trainees. They planned to impersonate a few of our Suffragettes. This event has been postponed due to the Pandemic, however we hope to eventually celebrate this memorable event! Dolores Mlynarczyk has been in contact with the Oregon Women's History Consortium, and is nominating our local Reed Opera House to include in the "site" of suffragette activity prior to August 26, the date when the 19th Amendment was added to the U.S. Constitution. Both Susan B. Anthony and Abigail Scott Duniway led activities at this location. The project of the Consortium is called "National Votes for Women Trail," and they are documenting where women's suffrage took place in the U.S. Dolores also arranged for a Proclamation to be issued on August 26, 2020, to commemorate the Centennial.

Mary Ellen Dello Stritto held our recent monthly board meetings via Zoom.

Yamhill County – We held Zoom meetings in May, June, and July. The business at hand during the June session was to discuss having a public presence to educate and remind the public about the importance of voting in November. Where we will most likely meet might be our Farmers' Market since the fall plans of Linfield University (restricted access) and Chemeketa Community College (exclusively distance learning) will make our presence on their respective campuses difficult to impossible. No date has been set for our next meeting, but we are hoping for September.

Hillsboro-Forest Grove—Claire Berger, President

The Hillsboro-Forest Grove Branch of AAUW has been busy these last few months trying to keep members connected with the Branch and with each other. We have been using three major strategies.

Our wonderful monthly newsletter organized and edited by member Ann Kubota is being circulated to members and branch friends monthly rather than taking the summer off as we have done in past years. We have also expanded the content to include events and opportunities for socially distant activities.

Monthly member meetings have been convened using Zoom and have included the League of Women Voters’ Redistricting Effort”, and a “Women’s History Webinar”. Happy Hour Socials were and are also being held monthly via Zoom focusing on fun topics.

Finally, a calling tree has been instituted to provide assistance and support when necessary so members feel connected to the branch and to each other. This is done on a monthly basis and includes all the members in the Branch.

The board evaluates the effectiveness of each of these strategies on a quarterly basis and crafts the next quarter of activities from lessons learned.

Lake Oswego — Mary Pat Silveira, President

Once it became apparent that we could not meet safely in person, Lake Oswego AAUW purchased a Zoom account and began to set up virtual meetings. This required a bit of a technological reach for many of us, but almost all members are now on board. We have been holding monthly board meetings via Zoom throughout this period in order to keep up to date with health conditions so we can fine-tune our decisions accordingly.

Almost all of our interest groups are continuing to meet, albeit virtually, including five of our six book groups, Lunch Bunch, Delightful Dining and Advocacy, plus we added a new storytelling group. Our centennial celebration of the adoption of the 19th Amendment, planned as a march through downtown Lake Oswego, also became a virtual event, and our monthly membership meetings will resume – on Zoom – in September. For those members who have chosen not to participate in Zoom meetings, we have established a buddy system to ensure that we contact them to see how they are doing. We decided to continue our online meetings at least until March, at which time we will re-evaluate the safety of our environment.

Oregon Online—Elena Rae, President

The Online Branch had a bit of a bubble when the newly elected president had to resign. I volunteered to

fill the spot, and was duly appointed by the board. I reached out to the two newest members, one in North Carolina, and one in California, asking them what had prompted them to join the branch. One of them wanted to talk via voice, as opposed to email, so we had a conversation about what online branches in other states are doing to stay connected during the pandemic. Our next branch meeting, in September, will be via Zoom. Previous meetings having been by conference call. I hope to contact a few more branch members by email and/or phone before then; just to get to know them a little bit.

Portland—Susan Marthens and Katie Raetz, Co-Presidents

Like the rest of the AAUW world, the Portland Branch has adapted to a new way of doing business and staying connected. We plunged into the world of Zoom and had our first Zoomed board meeting in April. Following that meeting, several board members took a portion of our membership roster of 100 and called each to say hello, touch base, and ascertain if they have computer access at home. Those of us who participated were touched by the positive responses to our calls! Many of our members live alone and are restricted in their ventures into the world of the pandemic. It was a reminder that we are a community and we do need to support each other.

We held our annual meeting in May—via Zoom again, thanks to Nancy Cheverton, our Communications Chair. At this time we elected and installed new officers. It was a positive ending for one year and a springboard into 2020-2021.

A variety of meetings and interest groups are also using this new way to communicate. Minor technical hiccups aside, the results are more than satisfactory—we don't have to wear masks to be together! Check out www.aauwpdx.org to view our programs.

Tigard—Ilga Ross and Marsha Brockmeyer, Co-presidents

At the July planning meeting, held via Zoom, the Tigard branch decided to hold all monthly programs through at least February 2021 via Zoom. We have eliminated the business portion in order to focus on the speakers. Starting us off in September, Mardy Stevens will share her experiences on the AAUW National board. We recommend that members view the webinar “State of the Association” in advance. The next speakers will be Kathy McAlpine, Tigard Police Chief, and Courtney Neron, Oregon State Representative. A readers’ theater presentation on women’s suffrage will highlight the December meeting. Social justice and support for recent immigrants start the new year.

Only one of our interest groups, the book group, is currently active. To encourage AAUW Fund giving, we will hold a drawing from donor members; prizes will be mailed directly from local businesses. Our “Clean Closets for College” fundraiser has been modified to be contactless and will be conducted in January. Most members seem to be very comfortable meeting from home via Zoom; branch officers have been amazing in their adaptability, and we expect our programs to be outstanding!

Northwest District Susan Wahlke, Director

Astoria—Liz Bartell, President

Board meetings continue monthly, at first via Google Hangout, and then Zoom. We did not have elections this spring. Board officers agreed to stay in place, at least for another year, except for one program co-
vp. Erin Engleson will take on the position, however limited our programs may be for the year. Erin has good computer skills so this is a very good thing!

Sara Meyer recently called and emailed last year’s members to encourage them to rejoin. A membership renewal form and reminder were sent out via our newsletter in late spring, but it resulted in few renewals, so it was felt that more assertive means were necessary. It’s typical of this branch to renew over a period of time during the summer. We will likely have about half the membership we had last year. The Board is discussing the future of our branch and how, in post-pandemic days, we might function as a smaller organization.

We have had a monthly newsletter, COLUMNS. Newer and longer-term members are featured in it, orchestrated by Sara Meyer. Our newsletter editor has resigned and we will recruit another editor from our membership or find a way to replace the newsletter with something simpler.

I recruited speakers and helped with the initial planning for the Summer Skills Camp Session on Mindfulness. Astoria Branch was also represented at three Summer Skills Camp sessions. We helped to circulate petitions for signature, supporting IP57. We are focusing on developing our Facebook Page. It's working. More attention is being paid to it. On behalf of Astoria AAUW, a letter to the editor was submitted decrying the murder of George Floyd and racism, which was published in *The Astorian*, our local newspaper.

A number of women in Astoria were asked by the editor of the local newspaper, *The Astorian*, to write essays for publication in the month of August. The topic assigned was personal reflections on Suffrage. I was included among those asked. At the bottom of my essay it will be noted that I'm the current president of Astoria AAUW.

We are planning a membership get-together in September that will primarily be a social event. We are working in conjunction with Clatsop Community College, *The Astorian*, and KMUN, our community radio station, for a Candidates' Forum scheduled for October 6th. A planning meeting is scheduled for early September when we will finalize the format for the Forum, and work out more details.

Lincoln City—Patty Heringer, president

The Lincoln City branch has focused on its commitment to providing scholarships to Taft High School girls' pursuit of higher education. Letters have been sent to members, former members, and former scholarship recipients requesting donations to the scholarship project. As an added incentive, an anonymous AAUW member will match each donation. It appears that at least two scholarships of \$1500 will be provided.

Our branch has also submitted its application for IRS non-profit status, thanks to treasurer, Jan Riedburger. Given that most of our branch members are in a vulnerable age group, we will not be holding in-person meetings until the Covid 19 crisis is over.
